CHANGE IN THE SHARE CAPITAL OF MFE-MEDIAFOREUROPE N.V.

MFE-MEDIAFOREUROPE N.V. ("MFE") hereby notifies the new composition of its subscribed and paid-up share capital following the cancellation of all the no. 88,707,693 ordinary shares MFE A (¹) held by MFE in its treasury (the "Treasury MFE Shares A") and the concurrent reduction of the issued share capital of MFE, in execution of the resolution adopted by the Extraordinary Shareholders' Meeting of MFE held on 15 March 2023. Consequently, the share capital, subscribed and paid-up, of MFE was reduced from Euro 813,569,533.02 to Euro 808,247,071.44.

On the date hereof, the declaration of no opposition from creditors has been issued by the competent court in accordance with Dutch laws and, therefore, the cancellation of all the Treasury MFE Shares A and the concurrent reduction of the issued share capital of MFE, resolved by the Extraordinary Shareholders' Meeting of MFE held on 15 March 2023, have been executed.

The Treasury MFE Shares A were acquired by MFE under the share buyback programme announced to the market on 20 July 2022, started on 25 July 2022, and completed on 30 November 2022. Such programme was aimed at reducing the share capital and has been carried our pursuant to Article 5 of Regulation (EU) no. 596/2014 of the European Parliament and of the Council of 16 April 2014.

The figure below describes the current composition of MFE's share capital, subscribed and paid-up, as well as the previous composition of the share capital.
